**SECTION 1.** HEREAFTER THE FINES FOR OWNERS WHO ALLOW HIS OR HER DOGS TO RUN AT LARGE UPON PUBLIC WAYS OF THE CITY OF DIAMOND CITY, ARKANSAS BOONE COUNTY WILL BE FINED \$25.00 FOR THE FIRST OFFENSE AND \$50.00 FOR ALL OFFENSES THEREAFTER.

SECTION 2. ALL ORDINANCES AND RESOLUTIONS AND PARTS THEREOF IN CONFLICT HEREIN ARE HEREBY REPEALED TO THE EXTENT OF SUCH CONFLICT.
