AN ORDNIANCE OF THE CITY OF DIAMOND CITY, AR. BOONE CO. AMENDING SECTION #4 OF THE ORDNIANCE #1-09 REGULAR SCHEDULED MEETINGS

BE IT ORDAINED: BY THE CITY COUNCIL OF THE CITY OF DIAMOND CITY, AR. BOONE CO. THAT SECTION #4 OF ORDNIANCE 1-09 BE AMENDED TO READ: REGULAR MEETINGS OF THE DIAMOND CITY ARKANSAS CITY COUNCIL WILL BE HELD AT 7:00 P.M. ON THE 1ST AND 3RD MONDAYS OF EACH MONTH, COMMENCING ON THE 1ST MONDAY OF AUGUST 2009.

SECTION 12 #1-09: REPEAL OF OTHER ORDIANCES. ALL ORDNIANCES OR PARTS THEROF IN CONFLICT HEREWITH ARE HEREBY REPEALED TO THE EXTENT OF SUCH CONFLICT.

SECTION 13 #1-09: EMERGENCY, AS PURSUANT TO THE ARKANSAS LAW ADOPTED BY THE ARKANSAS GENERAL ASSEMBLY AND AMENDMENTS THERETO, REQUIRES THE CITY COUNCIL TO MEET AT LEAST MONTHLY AT A SPECIFIED TIME AND PLACE, AND WHEREAS THE CITY COUNCIL AND /OR MAYOR, MAY CALL SPECIAL MEETINGS WITH A (6) SIX HOUR NOTIFICATION, AND WHEREAS CERTAIN NOTICES MUST BE GIVEN UNDER CERTAIN CIRCUMSTANCES BY ORDER OF LAW, AND WHEREAS, THE CITY COUNCIL AND/OF MAYOR HAS THE AUTHORITY TO REQUIRE CERTAIN PERSONS TO ATTEND THE SPECIAL AND REGULAR MEETINGS OF THE CITY COUNCIL AND TO GIVE, RECORD AND STORE CERTAIN INFORMATION AND RECORDS PERTAINING TO THE STATE, STATUS AND CONDITION OF THE CITY, AND WHEREAS, CERTAIN COMMITEES ORDAINED BY THE CITY SHALL FUNCTION RESPONSIVELY AND IMMEDIATELY FOR THE BENEFIT OF THE CITY; THEREFORE, IN ORDER TO COMPLY WITH LAWS OF THE STATE AND THE WORKLOAD OF THE GOVERNING BODY, AN EMERGENCY IS HEREBY DECLARED TO EXIST FOR THE CITY OF DIAMOND CITY, AND THIS ORDINANCE BEING NECESSARY FOR THE IMMEDIATE PERSEVERATION OF THE PUBLIC PEACE, HEALTH AND SAFETY SHALL BE IN FULL FORCE AND EFFECT FROM AND AFTER THE PASSAGE AND APPROVAL.
