ORDINANCE NO. 3-2012

CITY OF DIAMOND CITY, BOONE COUNTY, ARKANSAS

AN ORDINANCE PROVIDING LIMITS FOR ANY PURCHASES OR SPENDING OF CITY REVENUE FOR OR ON BEHALF OF THE CITY OF DIAMOND CITY NOT COVERED BY THE APPROVED BUDGET OF DIAMOND CITY

WHEREAS, overspending of City Revenues and decreased revenue coming into the city;

NOW THEREFORE, BE IT ORDAINED, by the City Council of the City of Diamond City,

SECTION 1. The City Council of Diamond City reduces the limit to zero (0) that any elected official or employee may spend outside of the approved operating budget.

SECTION 2. The City Council of Diamond City hereby enacts that any expenditures outside or above the operating budget of Diamond City shall go before the City Council of Diamond City for approval.

SECTION 3. The City Council appoints the Recorder/Treasurer or her Deputy Recorder as administrator of all Diamond City Credit Cards. Before any purchase on a Diamond City Credit card, that purchase shall be approved by the Recorder/Treasurer.

<u>SECTION 4.</u> PURCHASE ORDERS: All purchases for the City of Diamond City shall be on a Purchase Order. All Purchase Orders will be issued by the Recorder/Treasurer or her Deputy Recorder.

SECTION 5. The adoption of this Ordinance shall replace any Ordinance that is in conflict in part or whole.

SECTION 6. In the event any one or more of the provisions contained in this Ordinance shall for any reason be held by a Court of Law to be invalid, illegal or unenforceable in any respect, such invalidity, illegality or unenforceability shall not affect the remaining provisions of this Ordinance, and this Ordinance shall be construed as if such invalid, illegal or unenforceable provision or provisions had never been contained herein.

<u>EMERGENCY CLAUSE</u>. The City Council determines that this Ordinance is necessary for the provision of safe and proper oversight of the budget of the City of Diamond City. The City Council hereby declares this Ordinance to be an emergency and this Ordinance shall be in effect immediately.
