PARKS & RECREATION GRANT APPLICATION

REFURBISHMENT OF THE CITY PARK(S) & RESTROOM FACILITIES

CITY OF DIAMOND CITY, BOONE COUNTY, ARKANSAS

WHEREAS, DIAMOND CITY, ARKANSAS RECOGNIZES THE NEED TO PROVIDE SAFE PUBLIC RECREATION OPPORTUNITIES WITH MODERN UPDATED EQUIPMENT AND FACILITIES FOR ITS LOCAL CITIZENS AND VISITOR'S; AND

WHEREAS, THE CITY WISHES TO APPLY FOR REFURBISHMENT GRANT FUNDS THROUGH THE STATE OF ARKANSAS AND THE NORTH ARKANSAS ECONOMIC DEVELOPMENT DISTRICT TO UPGRADE IT'S CITY PUBLIC PARKS; AND

WHEREAS, THE MAYOR AND THE CITY COUNCIL UNDERSTAND THAT IF GRANTED FUNDS FOR PARK DEVELOPMENT AND/OR REFURBISHMENT, THEY MUST PROVIDE LAND, BY LEASE OR OWNERSHIP, ON WHICH TO DEVELOP UPDATED PARK FACILITIES; AND

WHEREAS, DIAMOND CITY, ARKANSAS WILL SIGN A CONTRACT AGREEING TO PROVIDE THE NECESSARY RESOURCES TO MAINTAIN THE PARKS AND FACILITIES FOR A PERIOD OF 25 YEARS;

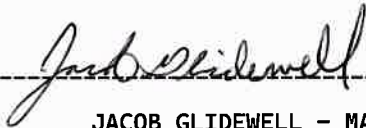
